CAMPGROUND

Campground: E1780 Equestrian Drive (off Miller Rd.)

The Association operates a State licensed campground. (County ordinances and the Covenants and Restrictions prohibit camping or storage of camping equipment on residential lots before a residence with full sanitary facilities has been built and is in use.) The campground is open to Association members, and also the public. A daily fee is charged for use of the campground.

17 of the 36 sites are designated as "seasonal" sites, one site is designated as the host camper's site. These sites are in high demand and are assigned on a lottery basis. This season runs from about mid-April to about mid-October each year.

The campground has a service building with toilets, showers, and coin-operated washers and dryers. Ice is available for sale at the clubhouse. Wood is available for sale, see the host camper.

The clubhouse/Association office, beach, and swimming pool are located at E2670 Clubhouse Drive. Phone: 608-985-7294.

CAMPGROUND RATES - Membership

Seasonal sites: \$1400/does not incl. pool or \$1525/incl. pool pass (designated by lottery drawing)

Primitive (tent only) area: \$22/day, \$110/week per tent* Based on two people per tent; max 2 pool passes per paid tent fee.

Water/Electric sites: (All water/electric sites have a designated parking space, a picnic table, and a fire ring.)

Tent camping (on improved site):

\$37/day, \$185/week*

Per tent & 4 people. \$2/person/day for additional people. Kids of any age included in this count. Extra tent, \$37/day. Max 2 tents/site. Max. 8 people.

Camping trailer or Pop-up:

\$50/day, \$250/week*

Per camper & 4 people. \$2/person/day for additional people. Kids of any age included in this count.

Only one camping trailer or pop-up per site. Extra tent, \$37/day. Max. 8 people.

ΔII sites.

- *Weekly rate pay for 5 nights, get 2 free. (Must be one continuous stay.)
- Use of the pool is included in your daily camping fees. You will be issued a pool pass upon registration for the total number of guests registered.
- HOLIDAY WEEKENDS: 2-night minimum stay. A \$25 security deposit per campsite is required to hold your reservation. Reservations will not be held if deposit not received within 10 days of request. Cancellation policy: Security deposit will be refunded in full if you cancel 7 days before your reservation. Deposit will be forfeited in the event of no-show or cancellation received less than 7 days before the reservation.
- If you arrive after the clubhouse closes in the evening, you must register and pay camping fees by **noon** the day after you set up camp. Penalty fee for non-compliance: \$5 per day.


General Public Campground Rates:

Primitive (tents only) area: \$30/day/tent/2 people

Water/electric sites:

\$53/day/tent camping on improved site/4 people; Extra tent, \$53/day. Max 2 tents/site. Max 8 people. \$66/day/camper or pop-up/4 people; Only 1 camper or pop up per site; Extra tent, \$53/day. Max 8 people. Additional people over the set maximums listed add \$3/person/day. See Campground Rules on Reverse

DHLPOA Campground Rules:

- All campers must register and pay the applicable fees at the Association office (located in the main clubhouse at E2670 Clubhouse Dr.). Late check-ins must register by **noon** the following day or will be subject to a late fee.
- Use of clubhouse facilities is included for registered daily campers. Required passes will be issued upon registration.
- No persons under 18 years old are permitted to use a campsite unless accompanied by an adult.
- Quiet hours are from 10 p.m. until 8 a.m.
- Observe the speed limit of 5 MPH (dead slow) on roads in the campground for the safety of children and reduction of noise and dust.
- NO firearms or fireworks allowed.
- No cutting or mutilating trees in any way. (This includes trees in the campground and the surrounding area.)
- Trees and the shade they provide are an integral part of an enjoyable campground experience. However, healthy, and well-maintained trees pose a natural hazard of falling debris, such as leaves and branches, especially during windy and/or extreme weather conditions. We do not assume responsibility for these natural hazards or for any property damage, injury or other circumstances that may result. Please take this into consideration when parking in the campground and while enjoying the area.
- Pets are welcome, but please keep them on a leash at all times outside of your camping unit. Do not leave them unattended, barking, or disturbing other campers. Pets must be current on all vaccinations. You are expected to clean up after your pet. Please dispose of pet droppings in a trash receptacle. Note: no pets are allowed in the clubhouse, swimming pool or campground service building (Wisconsin Statute, Board of Health). Pets are not allowed on beach or in picnic areas at the clubhouse.
- Parents are responsible for the actions of their minor children. Do not leave small children unsupervised at the campground.
- All water spigots have a vacuum breaker insert please insure this is left on! If missing, you will be charged a \$15 fee!
- Do not wash dishes in the service building. A sink is provided outside the service building, for that purpose.
- Fires are permitted in fire rings. Please do not move fire rings. The fire rings are for campfires, not burning garbage. Campfires must be attended at all times. (No glass, metal, aluminum, or any non-burnable items in fire pits.) For any garbage left in the fire pits, a \$25 fine will be charged.
- Dispose of all garbage in the dumpster provided for that purpose. Recycling is required; **sort** your garbage accordingly in the containers provided at the campground. Dumpster is for use by registered campers only.
- Park in designated gravel parking areas or on your assigned site. Angle parking is required in overflow parking areas. Campers/popups should be set up on the gravel pad only. Keeping grass areas open allows staff to efficiently and safely maintain the campground.
- Management reserves the right to limit the number of vehicles allowed.
- Keep the doors at the campground service building closed. Do not prop doors open for any reason.
- Before you check out of your site, place your picnic table on the gravel pad.
- Check out time is 12:00 noon.
- Camp at your own risk. In the event of emergency, call 911.
- To prevent the spread of the emerald ash borer, don't move firewood. Wood from out of state or more than 25 miles away is prohibited by the DNR.
- Conducting business, such as selling items/products, or performing services for pay is not allowed.
- Fines apply to those not complying with these rules.
- We reserve the right to evict, at our discretion and without refund, any person whose conduct is objectionable or violates campground rules.
- Help keep our campground clean. Dutch Hollow is beautiful. Let's keep it that way!
